CITY COUNCIL MEETING MINUTES Webster City, Iowa May 1, 2017

The City Council met in regular session at the City Hall, Webster City, Iowa at 5:30 p.m. on May 1, 2017, upon call of the Mayor and the advance agenda. The meeting was called to order by Mayor John Hawkins and roll being called there were present John Hawkins, Mayor in the chair, and the following Council Members: Matt McKinney, Brian Miller, Jim Talbot and Logan Welch.

It was moved by Talbot and seconded by Miller to approve the agenda.

ROLL CALL: Hawkins, McKinney, Miller, Talbot and Welch voting aye.

Mayor John Hawkins led the Pledge of Allegiance.

None brought forth.

PUBLIC INFORMATION

Council Member Welch invited those interested to attend the ribbon cutting of the new solar array at Little Wall Lake on Saturday, May 6th from 10 a.m. to noon. He also mentioned the St. Thomas Ball scheduled for that evening. A preview to the ball will be held Friday evening. He also commented on the Four Square Production Company that would be in town over the weekend to film a documentary.

12. It was moved by Miller and seconded by McKinney that Request from Webster City Lions Club to contribute \$10,000.00 for new playground equipment at Lions-Stafford Park be approved.

City Manager Ortiz-Hernandez reminded Council Members that this Park is a city owned property and with budgeted items coming in lower than anticipated, the funding is available

to help with this request.

13. A discussion was held on Animal Protection and Control, City Code Chapter 85. It was brought forth that the current Ordinance does not address when one animal attacks another animal. City Manager Ortiz-Hernandez presented an example of verbiage from another city's Ordinance that included several different options. Consensus of Council was to look at the Ordinance and amend to address this specific issue. City Attorney Chizek and Ortiz-Hernandez will draft the changes and provide to Council for review prior to placing on a meeting agenda.
