The City Council met in regular session at the City Hall, Webster City, Iowa at 5:30 p.m. on July 17, 2017, upon call of the Mayor and the advance agenda. The meeting was called to order by Mayor John Hawkins and roll being called there were present John Hawkins, Mayor in the chair, and the following Council Members: Brian Miller, Jim Talbot and Logan Welch. Presentations were given by applicants on July 6th, 2017 with the Board meeting on July 10, 2017 to determine final recommendations to present to Council.
