CITY COUNCIL MEETING MINUTES Webster City, Iowa May 7, 2018

The City Council met in regular session at the City Hall, Webster City, Iowa at 5:30 p.m. on May 7, 2018 upon call of the Mayor and the advance agenda. The meeting was called to order by Mayor John Hawkins and roll being called there were present John Hawkins, Mayor in the chair, and the following Council Members: Matt McKinney, Brian Miller, Jim Talbot and Logan Welch.

It was moved by McKinney and seconded by Miller to approve the agenda ROLL CALL: Hawkins, McKinney, Miller, Talbot and Welch voting aye

Mayor John Hawkins led the Pledge of Allegiance.

None brought forth.

PUBLIC INFORMATION

Mayor Hawkins reminded residents of the Clean Up/Drop Off Event scheduled for June 8, 2018 from noon to 4 p.m. and June 9, 2018 from 8 a.m. to 2 p.m. at the Middle School Parking Lot.

City Clerk Karyl Bonjour informed that applications are still being taken for the vacancies on City Boards and Commissions through Friday, May 11 at 5:00 p.m.

Council Member Welch noted that Teacher Amanda Nichols and a group of her students are sponsoring the movie "Radio" at the Webster City Theatre on May 21, 2018. Prior to the motion on Agenda Item Number 2, Developer Dave Walters of Green Stream Homes of Iowa gave an overview of the Planned Residential Units Project he would like to build East of Van Diest Medical Center and South along Edgewood Drive. The Development would include Apartment Complex(es), Town Homes, Independent Living, and eventually an Assisted Living Unit and a Nursing Home. Walters and Steve Troskey of CGA Engineers also answered questions from Council Members and those from the public who were in attendance at the meeting.
