Grant(s) Due Dates: The last grant application deadline was May 1, 2018. This deadline

was for the funding period of July 1, 2018- June 30, 2019.

Typical Award Amounts: \$5,000

Why this grant fits the needs of ACE:

The Iowa Depart of Cultural Affairs offers a Capacity Building Grant for non-profit culturally-based organizations with budgets less than \$150,000. The grant aids in funding for various cultural activities and art work organizations that contribute to the community. Specifically, the Capacity Building grant can be used to fund staff, space rental, and the purchases of supplies for volunteer purposes. Considering ACE's current funding is below \$150,000, cultural background and need to hire staff, this grant has the potential to be an excellent source of funding.
