The City Council met in regular session at the City Hall, Webster City, Iowa at 6:08 p.m. on March 16, 2020, upon call of the Mayor and the advance agenda. All Council Members were participating by phone with the meeting being called to order by Mayor John Hawkins and roll being called there were present by phone John Hawkins, Mayor, and the following Council Members: Katelin Hartmann, Matt McKinney, Brian Miller and Logan Welch.

It was moved by Miller and seconded by Hartmann to approve the agenda.

ROLL CALL: Hartmann, Hawkins, McKinney, Miller and Welch voting aye.

Mayor John Hawkins led the Pledge of Allegiance.

Public Works Director Ken Wetzler spoke on the two types of street light poles being considered for the Second Street Reconstruction Project.

It was moved by Hartmann and seconded by Welch that Resolution No. 2020-067 authorizing the Mayor and City Clerk to enter into a Structural Fire Training Agreement between the City of Webster City, Iowa, the Webster City Fire Department, and Kim Richardson and Christine Richardson in connection with property located at 845 Richardson Drive be passed and adopted.

12. It was moved by Hartmann and seconded by Miller that request from Street Supervisor to seek bids for setting footings for a building to be moved at the Street Department and approval to award the contract if the bids come in under budget be approved.

ROLL CALL: Miller, Welch, Hartmann, Hawkins and McKinney voting aye. Street Supervisor Brandon Bahrenfuss provided explanations for the requests pertaining to agenda items 11 & 12.

13. Discussion was held on the public Recycling Bin which is located at the Street Department, 100 East Ohio Street. Street Supervisor Brandon Bahrenfuss spoke with Council Members in regard to needing a third driveway entrance at the Street Department grounds which happens to be located where the current Recycle Bin sits. Discussion was held on the monthly costs as well as the extra service charges being charged for items left at the site that are not recyclable. Currently the County shares the expenses of this Bin. Bahrenfuss has been in touch with the County and they have expressed they are fine with removing the Bin altogether. It was suggested to see if the County would be willing to locate the Bin on any available property they would have, and in the interim until a further decision is made, the Bin can be relocated to a different area on the Street Department grounds.
