The City Council met in regular session at the City Hall, Webster City, Iowa at 6:08 p.m. on March 16, 2020, upon call of the Mayor and the advance agenda. All Council Members were participating by phone with the meeting being called to order by Mayor John Hawkins and roll being called there were present by phone John Hawkins, Mayor, and the following Council Members: Katelin Hartmann, Matt McKinney, Brian Miller and Logan Welch.

Bahrenfuss has been in touch with the County and they have expressed they are fine with removing the Bin altogether. It was suggested to see if the County would be willing to locate the Bin on any available property they would have, and in the interim until a further decision is made, the Bin can be relocated to a different area on the Street Department grounds.

SUMMARY: The City has received a Purchase Agreement from Lindsay Henderson to purchase 10' of a City-owned parcel located on E. Dubuque Street. A Public Hearing needs to be held prior to the disposal of this property.

PREVIOUS COUNCIL ACTION: On March 16, 2020, the City Council set April 6, 2020, at 6:05 p.m. as the time for a Public Hearing on this matter.

BACKGROUND/DISCUSSION: The City owns this parcel which had a vacant, dilapidated dwelling on it which we obtained through the Court system. Said dwelling was demolished in December of 2019 as we received no bids on it for rehabilitation. Lindsay Henderson owns the property to the east of it and is requesting to purchase 10' of the City property to resolve an issue of a shared driveway. Lindsay has offered \$1,270.50 and will be responsible for all associated costs. The offer price was established by taking the assessed value of the land and dividing it by the square footage.

The remaining portion of this parcel will be offered for sale in the near future by receiving sealed bids. The lot will still measure 64' x 165' which is large enough to build a home on should someone desire to do so.

FINANCIAL IMPLICATIONS: The money will be put in the General Fund.

RECOMMENDATION: Approve the Quit Claim Deed.

ALTERNATIVES: Council can choose not to sell this 10' strip with justification.

CITY MANAGER COMMENTS: I also recommend approval.

Public Hearing – Road Use Tax Revenue Loan

SUMMARY: I am seeking City Council authorization to enter into a new Road Use Tax Revenue Loan Agreement with Availa Bank for \$4,100,000. The issue will be used to finance the 2020 Second Street Reconstruction Project to include street, storm, water and sanitary as well as a portion of the Street Department Building.

PREVIOUS COUNCIL ACTION: Council participated in several discussions regarding financing current and future projects for the City. Michael Maloney with D.A. Davidson presented a plan to use road use tax receipts for our loan to pay for the 2020 Second Street Reconstruction Project and Street Department Building during a work session.

BACKGROUND/DISCUSSION: The City's Capital Improvement Plan includes several costly but needed projects. We will be using multiple financing sources to fund each project with the initial financing to be through a loan payable from road use tax receipts. The combined contracted project costs with engineering are \$6,243,216.71 (1,382,300.00-Building and 4,860,916.71-Street Reconstruction).

Michael Maloney presented two options for Jeff and I to consider, the local banks combining with Availa Bank as the lead with a 3.49% 5 year fixed interest rate or 3.6% fixed for the term of the loan.

FINANCIAL IMPLICATIONS: Funding will come from road use tax receipts, water, sewer and electric funds. The attached documents prepared by Michael Maloney shows the funding and loan details.

RECOMMENDATION: I recommend Council adopt the resolution to continue the borrowing process.

CITY MANAGER'S RECOMMENDATION: I wish to commend the Finance Director for her work on this project and we recommend approval of the resolution with the terms listed.

Financing Results for Second Street Reconstruction / Street Maintenance Building

The purpose of this correspondence is to provide information to related items on the April 6th Council meeting agenda. The City previously awarded construction bids on both the 2020 Second Street Reconstruction project and the 2020 Street Department Maintenance Building project. At the March 16th Council meeting, the City set the public hearing on financing of this project with a Road Use Tax Revenue Note for the April 6th meeting.

For your consideration on the April 6th agenda, the City's bond counsel (Dorsey) has prepared proceedings related to both holding the public hearing and approving the loan agreement with the selected investor for issuance of the Road Use Tax Revenue Note. These actions are consistent with the timeline reviewed with Council at the March 2nd meeting.

The public hearing will be held on the previously established not-to-exceed amount of \$4.3 million, which was a range determined prior to finalizing the ultimate funding sources for these projects. The final loan amount will be \$4.1 million after accounting for all related costs and funding sources. Davidson has worked closely with staff to determine the related amounts of both project costs and engineering expenses that will be paid by water, sewer and electric funds separate from this financing.

While this loan is structured as a long-term financing, please recall that the intent of this process was to provide maximum flexibility for the City in terms of repayment sources and debt capacity. The City will now have more financing options available when the balance of the Second Street Reconstruction project is bid and the City completes long-term analysis related to the Capital Improvement Plan. One of the key features is that this loan is redeemable at any time without penalty to the City and only at the City's option.

We solicited our wide network of potential investors, but felt it was important to also directly contact the local financial institutions to ensure they were given first and last opportunity. While not a typical loan for the local investors, Davidson felt it was important to spend the additional time to inform and guide these valuable City partners in what will result in a true community project.

Ultimately, three local institutions were willing to partner for the benefit of the City (Availa Bank – as lead bank, First State Bank and WCF Financial Bank). This team was willing to provide initial terms competitive with the broader market (3.49% initial interest rate) and also provide the flexibility the City was seeking.

At this time, Davidson recommends proceeding with the loan with Availa Bank (named bank for loan purposes as the lead). We will organize for the closing and delivery of funds on April 21st. I will continue to work with City staff to analyze long-term capital planning initiatives and look forward to building on the City's progress to date. Resolution approving a road use tax revenue loan agreement and authorizing the issuance of a \$4,100,000 Road Use Tax Revenue Note

WHEREAS, the City of Webster City, in the County of Hamilton, State of Iowa (hereinafter referred to as the "City") has proposed to enter into a Road Use Tax Revenue Loan Agreement (the "Loan Agreement") and issue Road Use Tax Revenue Notes, Series 2020 in a principal amount not to exceed \$4,300,000 (the "Notes"), pursuant to the provisions of Section 384.24A of the Code of Iowa, for the purpose of paying a portion of the cost, to that extent, of (1) constructing street improvements, including incidental storm water drainage, water system and sanitary sewer system improvements; and (2) constructing and equipping facilities useful for the provision and maintenance of the City's streets and related infrastructure (the "Project") and paying the costs of issuance associated with the Notes, and the City has published notice and held a hearing on such proposal on April 6, 2020; and

WHEREAS, pursuant to Section 364.6 of the Code of Iowa, the City elected to follow the procedures set forth in Sections 384.24A.5 and 384.83 of the Code of Iowa for the authorization of the Loan Agreement; and

WHEREAS, it has been proposed that the City enter into the Loan Agreement with Availa Bank, Webster City, Iowa and its permitted successors and assigns (the "Lender") and issue the Notes; and

NOW, THEREFORE, Be It Resolved by the City Council of the City of Webster City, Iowa, as follows:

The Loan Agreement is hereby approved, and the Mayor and City Clerk Section 1. are hereby authorized and directed to execute the Loan Agreement on behalf of the City. The Notes are hereby authorized to be issued in evidence of the obligation of the City under the Loan Agreement, in the total aggregate principal amount of \$4,100,000, to be dated the date of delivery. The Notes shall be issued as a single term note (the "Series 2020 Note"), and shall mature on June 1, 2035. The Series 2020 Note shall bear interest at the initial interest rate of 3.49% per annum through and including June 1, 2025; thereafter the interest rate shall adjust on June 1, 2025 and June 1, 2030 (each, a "Reset Date") to a rate (each, an "Adjusted Interest Rate") calculated on each Reset Date to be equal to the 5-year CMT Rate (as defined in the Series 2020 Note) plus 3.00%; provided, however, the Adjusted Interest Rate shall not be less than 3.49% and shall not exceed the interest rate in effect immediately prior to the rate adjustment by more than 2%, as provided in the Series 2020 Note. Interest of the Series 2020 shall be payable on each June 1 and December 1, commencing December 1, 2020. Principal of the Series 2020 Note shall be payable on June 1 in each of the years and in such amounts as follows:

The City reserves the right to optionally prepay principal of the Series 2020 Note in whole or in part on any date as provided in the Series 2020 Note.

Section 2. The City Clerk is hereby designated as the Registrar and Paying Agent for the Series 2020 Note and may be hereinafter referred to as the "Registrar" or the "Paying Agent".

Section 3. Payment of interest on and principal of the Series 2020 Note shall be made to the registered owners appearing on the registration books of the City at the close of business on the fifteenth day of the month next preceding the interest or principal payment date and shall be paid by electronic wire transfer or by check or draft mailed to the registered owners at the addresses shown on such registration books, provided that the final payment of principal shall be made only upon presentation and surrender of the Series 2020 Note at the office of the Paying Agent.

The Series 2020 Note shall be executed on behalf of the City with the official manual or facsimile signature of the Mayor and attested with the official manual or facsimile signature of the City Clerk, and shall be a fully registered Series 2020 Note without interest coupons. The issuance of the Series 2020 Note shall be recorded in the office of the City Treasurer, and the certificate on the back of the Series 2020 Note shall be executed with the official manual or facsimile signature of the City Treasurer. In case any officer whose signature or the facsimile of whose signature appears on the Series 2020 Note shall cease to be such officer before the delivery of such Series 2020 Note, such signature or such facsimile signature shall nevertheless be valid and sufficient for all purposes, the same as if such officer had remained in office until delivery.

The Series 2020 Note shall not constitute a general obligation of the City but will be payable solely and only from annual road use tax funds received by the City from the State of Iowa (the "State Road Use Taxes"). The City Council hereby covenants to appropriate to its City RUT Fund (as hereinafter defined) in each year so long as the Series 2020 Note is outstanding a sufficient amount of the State Road Use Taxes to pay interest on and principal of the Series 2020 Note as such payments become due, and the City hereby pledges the City RUT Fund for the full and prompt payment of the principal of and interest on the Series 2020 Note. The City shall not be liable in any manner whatsoever for any shortfall in the disbursement of



the State Road Use Taxes by the State of Iowa resulting in insufficient funds being available in the City RUT Fund to pay debt service on the Series 2020 Note.

Principal of the Series 2020 Note and the interest thereon, together with any additional obligations as may be hereafter issued and outstanding from time to time ranking on a parity therewith under the conditions set forth herein (which additional obligations are hereinafter sometimes referred to as "Parity Obligations"), shall be payable solely from the City RUT Fund and the Sinking Fund hereinafter referred to, both of which are hereby pledged to the payment of the Series 2020 Note.

The Series 2020 Note shall be fully registered as to principal and interest in the names of the owners on the registration books of the City kept by the Registrar, and after such registration, payment of the principal and interest thereof shall be made only to the registered owners, their legal representatives or assigns. The Series 2020 Note shall be transferable only upon the registration books of the City upon presentation to the Registrar, together with either a written instrument of transfer satisfactory to the Registrar or the assignment form thereon completed and duly executed by the registered owner or the duly authorized attorney for such registered owner.

Section 4. The Series 2020 Note shall be in substantially the following form:

This Note is issued by the City to evidence its obligation under a certain Road Use Tax Revenue Loan Agreement (the "Loan Agreement"), entered into by the City for the purpose of paying a portion of the costs of the Project (as defined in the hereinafter referred to Resolution) and paying costs of issuance associated with the Note.

This Note is issued pursuant to and in strict compliance with the provisions of Sections 364.6, 384.24A and 384.83 of the Code of Iowa, and all other laws amendatory thereof and supplemental thereto, and in conformity with a resolution of the City Council authorizing and approving the Loan Agreement and providing for the issuance and securing the payment of this Note (the "Resolution"), and reference is hereby made to the Resolution and the Loan Agreement for a more complete statement as to the source of payment of this Note and the rights of the owners of this Note. Capitalized terms nor otherwise defined herein shall have the meaning as forth in the Resolution.

Payment of interest on and principal of this Note shall be made to the registered owner appearing on the registration books of the City at the close of business on the fifteenth day of the month next preceding the interest or principal payment date and shall be paid by electronic wire transfer or by check or draft mailed to the registered owner at the address shown on such registration books, provided that the final payment of principal shall be made only upon presentation and surrender of this Note at the office of the Paying Agent.

The City reserves the right to optionally prepay principal of the Series 2020 Note in whole or in part on any date prior to and in inverse order of maturity on terms of par and accrued interest upon thirty (30) days' notice to the Lender.

This Note is not a general obligation of the City but, together with any additional obligations as may be hereafter issued and outstanding from time to time ranking on a parity therewith under the conditions set forth in the Resolution, is payable solely and only from annual road use tax funds received by the City from the State of Iowa (the "State Road Use Taxes"). In and by the Resolution, the City Council has covenanted to appropriate to its Road Use Tax Fund (the "City RUT Fund") in each year so long as this Note is outstanding a sufficient amount of the State Road Use Taxes to pay interest on and principal of this Note as such payments become due, and the City has pledged the City RUT Fund for the full and prompt payment of the principal of and interest on this Note. Under no circumstances shall the City be in any manner liable by reason of the failure of the said State Road Use Taxes to be sufficient for the payment of this Note and the interest hereon.

This Note is fully negotiable but shall be fully registered as to both principal and interest in the name of the owner on the books of the City in the office of the Registrar, after which no transfer shall be valid unless made on said books and then only upon presentation of this Note to the Registrar, together with either a written instrument of transfer satisfactory to the Registrar or the assignment form hereon completed and duly executed by the registered owner or the duly authorized attorney for such registered owner.

The City, the Registrar and the Paying Agent may deem and treat the registered owner hereof as the absolute owner for the purpose of receiving payment of or on account of principal hereof, premium, if any, and interest due hereon and for all other purposes, and the City, the Registrar and the Paying Agent shall not be affected by any notice to the contrary.

Section 5. The Series 2020 Note shall be executed as herein provided as soon after the adoption of this resolution as may be possible and thereupon shall be delivered to the Registrar for registration, authentication and delivery to the Lender, upon receipt of the loan proceeds (the "Proceeds"), and all action heretofore taken in connection with the Loan Agreement is hereby ratified and confirmed in all respects.

The Proceeds received from the Series 2020 Note shall be deposited into a special account held by the City (the "Project Fund") and applied (1) to pay costs of the Project and (2) to pay issuance expenses related to the Series 2020 Note. Any unexpended balance of the proceeds of the Series 2020 Note remaining thereafter shall be converted into the Sinking Fund hereinafter referred to and used to pay interest on the Series 2020 Note on the next succeeding interest payment date, or otherwise applied as approved by an opinion of Bond Counsel.

Section 6. From and after the delivery of the Series 2020 Note and as long as any of the Series 2020 Note and any Parity Obligations are outstanding and unpaid or until all principal of and interest thereon have been discharged and satisfied or provision therefor has been made, 100% of the State Road Use Taxes received by the City after the date of issuance of the Series 2020 Note, shall be deposited as collected in the City's Road Use Tax Revenue Fund (the "City RUT Fund"), which shall be used and disbursed as hereinafter provided to pay the principal of and interest on all of the Series 2020 Note and any Parity Obligations outstanding from time to time, as the same become due, and to create and maintain the several separate funds hereinafter established, or established in the future pursuant to the issuance documents for the Parity Obligations.

A. <u>Sinking Fund.</u> There shall be continued and maintained the account known as the "Road Use Tax Revenue Sinking Fund" (herein referred to as the "Sinking Fund"), into which there shall continue to be set aside from the State Road Use Taxes such portion thereof as will be sufficient to pay the interest on and principal of the Series 2020 Note as the same become due, and it is hereby determined that the minimum amount to be so set aside into the Sinking Fund from the State Road Use Taxes with respect to the Series 2020 Note during each month of each year shall be the amount sufficient to pay the interest on and principal of the Series 2020 Note due each month as provided in the Series 2020 Note.

Provided, however, that no further payments need be made into the Sinking Fund when and so long as the amount therein is sufficient to retire the Series 2020 Note and any Parity Obligations then outstanding which are payable from the Sinking Fund and to pay all principal and interest to become due thereon prior to such retirement, or if provision for such payment has been made. All such payments into the Sinking Fund shall be made in equal monthly installments on the first day of each month, except that when the first day of any month shall be a Sunday or a legal holiday, then such payments shall be made on the next succeeding secular day, and that portion of the State Road Use Taxes on deposit in the Sinking Fund shall be used solely and only and is hereby pledged for the purpose of paying the principal of and interest on the Series 2020 Note and any Parity Obligations as the same shall become due and payable.

Whenever Parity Obligations are issued under the conditions and restrictions hereinafter set forth, provisions shall be made for additional payments to be made into the Sinking Fund for paying the interest on and principal of such Parity Obligations.

If at any time there be a failure to pay into the Sinking Fund the full amount above stipulated, then an amount equivalent to the deficiency shall be paid into the Sinking Fund from the State Road Use Taxes as soon as available, and the same shall be in addition to the amount otherwise required to be so set apart and paid into the Sinking Fund.

B. <u>Surplus Fund</u>. There is hereby created a special fund to be known and designated as the Surplus Fund into which there shall be set apart and paid all of the State Road Use Taxes remaining after first making the required payments into the Sinking Fund. All money credited to the Surplus Fund shall be transferred and credited to the Sinking Fund whenever necessary to prevent or remedy a default in the payment of the principal of or interest on the Series 2020 Note and any Parity Obligations.

As long as the Sinking Fund has the full amount required to be deposited therein by this resolution, any balance in the Surplus Fund may be used in such legal manner as the City Council, or such other duly constituted body as may then be charged with the expenditure of the State Road Use Taxes, may from time to time direct.

Whenever Parity Obligations are issued under the conditions and restrictions hereinafter set forth and under the respective issuance documents, provisions may be made for additional funds and accounts to be established pursuant to such issuance documents, including without limitation a debt service reserve fund pledged solely to the payment of such Parity Obligation, and the City may provide for deposits to such funds and accounts from State Road Use Taxes after the monthly funding of the Sinking Fund has been satisfied, as provided herein.

Section 7. All money held in any fund created or to be maintained under the terms of this resolution shall be deposited in lawful depositories of the City or invested in accordance with Chapters 12B and 12C of the Code of Iowa and continuously held and secured as provided by the laws of the State of Iowa relating to the depositing, securing, holding and investing of public funds. All interest received by the City as a result of investments under this section shall be deposited in or transferred to the Sinking Fund and used solely and only for the purposes specified herein for such fund.

Section 8. The City hereby covenants and agrees with the owner or owners of the Series 2020 Note and any Parity Obligations, or any of them, that from time to time may be outstanding, that it will faithfully and punctually perform, or caused to be performed, all duties with respect to the State Road Use Taxes required by the Iowa Constitution and laws of the State of Iowa and this resolution, including without limitation, the proper segregation of the State Road Use Taxes and make application thereof in accordance with the provisions of this resolution. The City shall, to the extent permitted by law, defend the validity and legality of this resolution and the State Road Use Taxes against all claims, suits and proceedings which would diminish or impair the State Road Use Taxes as security for the Series 2020 Note and any Parity Obligations. The City, its officers, agents and employees, shall not take any action

in such manner or to such extent as might prejudice the security for the payment of the Series 2020 Note and any Parity Obligations according to the terms thereof.

Section 9. Upon an Event of Default (as defined in the Loan Agreement) declared by the Lender in writing to the City, except as herein expressly limited, the owner or owners of the Series 2020 Note shall have and possess all the rights of action and remedies afforded by the common law, the Constitution and statutes of the State of Iowa and of the United States of America for the enforcement of payment of the Series 2020 Note and the interest thereon and of the pledge of the State Road Use Taxes and of all covenants of the City hereunder.

Section 10. The Series 2020 Note or any Parity Obligations shall not be entitled to priority or preference one over the other in the application of the State Road Use Taxes regardless of the time or times of the issuance of the Series 2020 Note or any Parity Obligations, it being the intention that there shall be no priority among the Series 2020 Note or Parity Obligations, regardless of the fact that they may have been actually issued and delivered at different times. The City hereby covenants and agrees that so long as the Series 2020 Note or any Parity Obligations are outstanding and unpaid, no bonds or other obligations payable from the State Road Use Taxes or the City RUT Fund will be issued except upon the basis of such bonds or obligations being subject to the priority and security for payment of the Series 2020 Note or any Parity Obligations then outstanding; provided, however, that the City reserves the right and privilege of issuing Parity Obligations for any lawful purpose, but only if the officially reported State Road Use Taxes for the last preceding fiscal year prior to the issuance of such Parity Obligations (with adjustments as hereinafter provided) were equal to at least 125% of the maximum amount of principal and interest that will become due in any subsequent year during the life of the Series 2020 Note and any Parity Obligations then outstanding, for the Series 2020 Note and any Parity Obligations then outstanding and the Parity Obligations then proposed to be issued.

For the purpose of determining the State Road Use Taxes for the preceding fiscal year as aforesaid, the amount of the State Road Use Taxes for such year may be adjusted by an independent certified public accountant, auditor or financial advisor, so as to reflect any changes in the amount of the State Road Use Taxes which would have resulted had any revision of the rate, formula or funding levels for distribution of the State Road Use Taxes by the State of Iowa, imposed at or prior to the time of the issuance of any such Parity Obligations been in effect during all of such preceding fiscal year. For the purposes of this provision, the independent certified public accountant, auditor or financial advisor may treat any current projections of State Road Use Taxes of the State of Iowa as if such projections had been in effect for the preceding fiscal year (including without limitation adjustment in the rate, formula or funding levels by the State of Iowa).

Obligations issued to refund the Series 2020 Note or any Parity Obligations shall not be subject to the foregoing restrictions, provided the Series 2020 Note or Parity Obligations being refunded will be redeemed within three (3) months of the date of such refunding, and the issuance of the refunding obligations will not cause an increase in the annual debt service requirements during the life of the Series 2020 Note or Parity Obligations then outstanding

which are not being refunded but otherwise any Parity Obligations shall only be issued subject to the restrictions of this resolution.

Section 11. The provisions of this resolution shall constitute a contract between the City and Lender and any holders of Parity Obligations. For any one or more of the following purposes, but without the consent of or notice to the Lender or any Parity Obligations, and at any time or from time to time this Resolution may be amended, modified or supplemented by the City:

- (a) to cure any ambiguity or formal defect or omission in this Resolution;
- (b) to grant to or confer for the benefit of the Lender or owners of Parity Obligations any additional rights, remedies, powers or authority that may lawfully be granted to or conferred upon the Lender or the owners of the Parity Obligations;
- (c) to assign and pledge under this Resolution additional revenues, properties or collateral as permitted by law;
- (d) to modify, amend or supplement this Resolution in such manner as to permit continued compliance with the provisions of the Code in order to maintain the tax exempt status of the Series 2020 Note and any Parity Obligations;
- (e) to provide for the issuance or incurrence of Parity Obligations or subordinate obligations in accordance herewith; and
- (f) to make any other change that does not materially adversely affect the rights of any of the owners of the Series 2020 Note.
- Section 12. <u>Amendment of Resolution Requiring Consent.</u> In addition to amendments to this Resolution authorized by Section 11 hereof, this Resolution may be amended from time to time if such amendment shall have been consented to by the holders of not less than two-thirds in principal amount of the Series 2020 Note at any time outstanding; provided, however, this Resolution may not be so amended without the consent of the holders of 100% in principal amount of the Series 2020 Note at the time outstanding in such manner as to:
- (a) Make any change in the maturity or interest rate of the Series 2020 Note, or modify the terms of payment of principal of or interest on the Series 2020 Note or any of them or impose any conditions with respect to such payments;
- (b) Materially affect the rights of the holders of the Series 2020 Note then outstanding; and
 - (c) Reduce the percentage of the principal amount of the Series 2020 Note.

Whenever the City shall propose to amend or modify this Resolution under the provisions of this section, it shall cause notice of the proposed amendment to be mailed to each

of the owners of the Series 2020 Note at the addresses appearing on the registration books of the City held by the Bond Registrar and also to the holders of the Series 2020 Note. Such notice shall briefly set forth the nature of the proposed amendment and shall state that a copy of the proposed amendatory resolution is on file in the office of the Board Secretary.

If the owners of not less than two-thirds in aggregate principal amount of the Series 2020 Note outstanding at the time of the adoption of such amendatory resolution shall have consented to and approved the adoption thereof as herein provided, no owner of any Series 2020 Note shall have any right or interest to object to the adoption of such amendatory resolution or to object to any of the terms or provisions therein contained or to the operation thereof or to enjoin or restrain the City from taking any action pursuant to the provisions thereof.

Any consent given by the owners of a Series 2020 Note pursuant to the provisions of this section shall be irrevocable for a period of six (6) months from the date of such consent and shall be conclusive and binding upon all future owners of the same Series 2020 Note during such period. Such consent may be revoked at any time after six (6) months from the date of such consent by the owner who gave such consent or by a successor in title, but such revocation shall not be effective if the owners of not less than two-thirds in aggregate principal amount of the Series 2020 Note outstanding as in this section defined, shall have, prior to the attempted revocation, consented to and approved the amendatory resolution referred to in such revocation.

The fact and date of the execution of any instrument under the provisions of this section may be proved by the certificate of any officer in any jurisdiction who by the laws thereof is authorized to take acknowledgments of deeds within such jurisdiction, that the persons signing such instrument acknowledged before such officer the execution thereof, or may be proved by an affidavit of a witness to such execution sworn to before such officer.

Section 13. The Securities and Exchange Commission (the "SEC") has promulgated certain amendments to Rule 15c2-12 under the Securities Exchange Act of 1934 (17 C.F.R. § 240.15c2-12) (the "Rule") that make it unlawful for an underwriter to participate in the primary offering of municipal securities in a principal amount of \$1,000,000 or more unless, before submitting a bid or entering into a purchase contract for such securities, it has reasonably determined that the issuer or an obligated person has undertaken in writing for the benefit of the registered owners of such securities to provide certain disclosure information to prescribed information repositories on a continuing basis so long as such securities are outstanding or unless and to the extent the offering is exempt from the requirements of the Rule because the issue is issuable in denominations of \$100,000 or more (subject to certain qualifications regarding deep discount securities) and (i) are sold in a limited private placement; or (ii) have a maturity of nine months or less; or (iii) are subject to tender at par at the option of the registered owner at least every six months.

The Series 2020 Note is being issued in a minimum denomination of more than \$100,000 and is being sold in a limited private placement. Accordingly, the City finds that the Rule is inapplicable to the Series 2020 Note.



Section 14. It is the intention of the City that interest on the Series 2020 Note be and remain excluded from gross income for federal income tax purposes pursuant to the appropriate provisions of the Internal Revenue Code of 1986, as amended, and the Treasury Regulations in effect with respect thereto (all of the foregoing herein referred to as the "Internal Revenue Code"). In furtherance thereof the City covenants to comply with the provisions of the Internal Revenue Code as they may from time to time be in effect or amended and further covenants to comply with applicable future laws, regulations, published rulings and court decisions as may be necessary to insure that the interest on the Series 2020 Note will remain excluded from gross income for federal income tax purposes. Any and all of the officers of the City are hereby authorized and directed to take any and all actions as may be necessary to comply with the covenants herein contained.

The City hereby designates the Series 2020 Note as a "Qualified Tax Exempt Obligation" as that term is used in Section 265(b)(3)(B) of the Internal Revenue Code.

- Section 15. If any section, paragraph, clause or provision of this resolution shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this resolution.
- Section 16. This resolution shall be governed by, and construed in accordance with, the laws of the State of Iowa without regard to choice of law rules of the State of Iowa.
- Section 17. The Mayor and the City Clerk (or their designee) are hereby authorized to execute and deliver any and all agreements, documents and instruments required related to the issuance of the Series 2020 Note and to carry out the purposes set forth in this resolution, including but not limited to any tax certificates, closing certificates, covenant agreements and purchase agreements.
- Section 18. All resolutions and orders or parts thereof in conflict with the provisions of this resolution are, to the extent of such conflict, hereby repealed.
- Section 19. This resolution shall be in full force and effect immediately upon its adoption and approval, as provided by law.

LOAN AGREEMENT (Road Use)

This Loan Agreement is entered into as of April 21, 2020, by and between the City of Webster City, Iowa (the "City"), and Availa Bank (the "Lender"). The parties agree as follows:

- 1. The Loan. The Lender shall loan to the City the sum of \$4,100,000, and the City's obligation to repay hereunder shall be evidenced by the issuance of a Road Use Tax Revenue Note, Series 2020, in the principal amount of \$4,100,000 (the "Note").
- 2. The Resolution; Pledge of Security. The City Council of the City adopted a resolution on April 6, 2020 (the "Resolution") authorizing and approving this Loan Agreement and providing for the issuance of the Note for the purpose or purposes set forth in the Resolution. The Resolution is incorporated herein by reference, and capitalized terms used herein and not otherwise defined herein shall have the meaning set forth in the Resolution. The parties agree to abide by the terms and provisions of the Resolution. Principal of the Note and the interest thereon, together with any Parity Obligations as may be hereafter issued and outstanding from time to time under the conditions set forth in the Resolution, shall be payable solely and only from the Road Use Tax Fund, a sufficient portion of which has been ordered set aside and pledged for such purpose under the provisions of the Resolution.
- 3. <u>Use of Proceeds.</u> The loan proceeds shall be used to pay costs of the Project, including costs of issuance.
- 4. The Note. The Note, in substantially the form set forth in the Resolution, shall be executed and delivered to the Lender to evidence the City's obligation to repay the amounts payable hereunder. The Note shall be registered in the name of the Lender, dated the date of delivery, shall bear interest, shall be payable as to principal and interest on the dates and in the amounts, shall not be subject to prepayment prior to maturity and shall contain such other terms and provisions as provided in the Note and the Resolution.

The City and the Lender acknowledge and agree as follows: (i) neither party has applied for or received a rating on the Note from any rating agency; (ii) no official statement has been or will be prepared in connection with the private placement of the Note; and (iii) no CUSIP numbers will be obtained for the Note.

- 5. Not a General Obligation. Neither this Loan Agreement nor the Note shall constitute a general obligation of the City, nor be payable by taxation, and under no circumstances shall the City be in any manner liable by reason of the failure of the State Road Use Taxes to be sufficient to pay the principal of the Note and the interest thereon or to otherwise discharge the City's obligation hereunder. This Loan Agreement is executed pursuant to the provisions of Section 384.24A of the Code of Iowa and shall be read and construed as conforming to all provisions and requirements of the statute.
- 6. Counterparts. This Loan Agreement may be executed in any number of counterparts and by the different parties hereto on separate counterparts each of which, when so executed, shall be deemed an original, but all such counterparts shall constitute but one and the same instrument.
- 7. Term. This Loan Agreement shall continue in full force and effect from and after the date hereof until the Note and the payment obligations thereunder and under this Loan Agreement have been fully paid and discharged.
- 8. Notices. All notices, requests, demands, directions and other communications (collectively "notices") under the provisions of this Loan Agreement shall be in writing (including e-mail and facsimile communication), and shall be sent by first class mail or overnight delivery and shall be deemed received as follows: (i) if by first class mail, five (5) days after mailing; (ii) if by overnight delivery, on the next Business Day; (iii) if by telephone, when given to a person who confirms such receipt; and (iv) if by facsimile or e-mail, when confirmation of receipt is obtained. All notices shall be sent to the applicable party at the following address or in accordance with the last unrevoked written direction from such party to the other parties hereto:

It is my understanding that we will be reimbursed for leave paid out under the provisions of this act. The instructions for doing so will be coming in the future.

AMENDED LEAVE POLICY DURING COVID-19 EMERGENCY

Since the President of the United States signed a law increasing leave benefits in times of COVID-19 pandemic, and the Governor of lowa has declared a state of emergency due to pandemic conditions of the COVID-19 virus, the City of Webster City will amend the standard leave policies. Upon approval by the City Council on April 6, 2020, the amendment will be in effect retroactively from April 1, 2020 until no later than December 31, 2020.

The following policy amendment meets or exceeds the requirements of the Families First Coronavirus Response Act (FFCRA).

The purpose of COVID-19 leave is to provide some relief to employees dealing with the impact of COVID-19. <u>Employees may be eligible to use up to 80 hours total of COVID-19 leave in any combination</u>, paid at their regular rate of pay, if they are experiencing one of the following circumstances. Any unused leave will not rollover.

ABSENCES ELIGIBLE FOR COVID-19 LEAVE

For employees quarantined or sick with COVID-19

The City will grant up to 80 hours of paid COVID-19 leave* to employees who have been required or advised to quarantine by a medical provider or a county, state, or federal agency, or who have been advised by a medical provider they have confirmed or presumptively confirmed COVID-19. Employees must complete a Request for COVID-19 Leave form and provide it to Human Resources before the special pay will be granted. If the employee is unable to return to work after the COVID-19 leave has been exhausted, they may use accrued and unused sick leave, vacation leave, or compensatory time to cover their remaining absence.

Employees must follow CDC or Iowa Department of Public Health guidelines for returning to work after the illness.

*all COVID-19 leave will be prorated for part-time employees.

For employees caring for an individual quarantined or sick with COVID-19

The City will grant up to 80 hours of paid COVID-19 leave* to those employees providing direct care for an individual required or advised to be quarantined by a medical provider, or a county, state, or federal agency, or an individual who has been advised by a medical provider they have confirmed or presumptively confirmed COVID-19. Employees must complete a Request for COVID-19 Leave form and provide it to Human Resources before the special pay will be granted. If the employee continues to care for the individual after the COVID-19 leave has been exhausted, they may use accrued and unused family sick leave, vacation leave, or compensatory time to cover their remaining absence. Absences longer than two weeks must have documentation certifying additional leave is necessary.

Based on minimum staffing needs required to maintain operations, the City may exempt employees serving in an emergency responder role from this provision of COVID-19 leave.

Employees must follow CDC or lowa Department of Public Health guidelines for returning to work after caring for an individual impacted by COVID-19.

*all COVID-19 leave will be prorated for part-time employees.

For employees with children impacted by school district/daycare closures

This section serves as a "qualifying need related to a public health emergency" under the FFCRA.

If schools or daycare facilities where the children of employees attend close due COVID-19, the City will make every effort to adjust hours, create an alternative work schedule, or identify an alternative childcare arrangement in order to maintain services. If no alternative work solutions are appropriate, the City will grant COVID-19 leave* to cover up to 80 hours of the closure. Employees must complete a Request for COVID-19 Leave form and provide it to Human Resources before the special pay will be granted. If the employee is unable to return to work after the COVID-19 leave has been exhausted, they will receive 2/3 of their normal pay for up to an additional 400 hours. Employees may use accrued and unused sick leave, vacation leave, or compensatory time to cover the remaining 1/3 of their pay.

In general, COVID-19 leave will only be granted during the hours a child would normally be in school or daycare and only to those who are not able to adjust their hours or work from home, where alternative childcare is unavailable, AND whose children:

- Are under the age of 18
- Attend daycare or a K-12 school, or
- Have special needs and would be unable to care for themselves while their parents are at work.

Based on minimum staffing needs required to maintain operations, the City may exempt employees serving in an emergency responder role from this provision of COVID-19 leave and/or FFCRA family leave.

*all COVID-19 leave will be prorated for part-time employees.

ABSENCES NOT ELIGIBLE FOR COVID-19 LEAVE

For employees choosing to self-isolate

Employees who are not required or advised by a medical provider or any county, state, or federal agency to be quarantined and choose to self-isolate must use accrued and unused vacation leave, accrued and unused compensatory time, or leave without pay to cover their absence. As with any form of voluntary leave, these absences must be approved by the employee's supervisor.

In all cases of absence, employees must provide current contact information (including phone number and email address) to their supervisor.

SUMMARY: I am asking Council to adopt a new resolution regarding the maximum property tax dollars on certain levies for the FY21 budget.

DISCUSSION: A public hearing was held on March 2, 2020 to approve the maximum property tax dollars on certain levies for the FY21 budget in accordance with SF634. At the hearing, Council did not receive any written objections nor were any oral objections presented.

The language in the resolution presented to Council at the March 2, 2020 public hearing did not state the specific property tax amount asking on certain levies for the FY21 budget.

Ted Nelleson with the lowa Department of Management has advised that the adopted resolution needs to state the amount of property tax dollars the city is asking for and if the asking is more or less than 2% from the previous fiscal year. He also advised we do not need to hold another public hearing but need the new resolution passed and adopted with a two-thirds roll call vote.

FINANCIAL IMPLICATIONS: The tax asking for FY21 will be \$3,354,318 from the specific levies determined by the State and shown on the public hearing notice. The FY21 tax asking is an additional \$144,349 from FY20 which calculates to 4.5%. The overall levy is 16.24200.

RECOMMENDATION: I recommend approving the amended resolution to be in compliance with the state requirements.

CITY MANAGER COMMENTS: I agree with the recommendation of the Finance Director.

Update on Properties Under Contract with the City

SUMMARY: Four bids were accepted by the City Council for 4 City-owned properties on February 18, 2019. Each bidder entered into a contract with the City which gave them until February 19, 2020 to have their rehab project completed.

PREVIOUS COUNCIL ACTION: N/A

BACKGROUND/DISCUSSION: The deadline for all four parcels has expired as of February 19, 2020. No project has been completed. The following gives an update of each property:

- 1) 806 Stockdale Street Elise and Jeremy Timm See attached picture #1. Nothing has been started. Have received no response from letters sent to them, texts sent to them or phone messages left for them. Our City Attorney has advised that a 30-day notice will be served on them and then he will file an affidavit with the Recorder's office to have the title put back in the City's name.
- 2) 827 Water Street Tony and Betty Sponsel See attached picture #2. The Sponsel's worked hard on it last spring and summer. They have spent thousands of dollars on repairs including a new roof, water and sewer line repairs, kitchen repairs, basement windows and foundation repairs. They left for the winter and will be back soon to resume rehabilitation measures including completion of new electric and plumbing and to finish the kitchen.
- 3) 921 James Street Russell Mourton See attached picture #3. Russ has replaced some of the siding and all the windows. Nothing has been done on the inside. After Cory inspected it earlier this month, Cory sent a letter to Russ stating his concerns regarding structural issues and load bearing concerns. He suggested that Russ get a structural engineer to address these issues. Cory has met with his engineer who confirmed Cory's concerns. Russ is requesting 2 more years to complete his project.
- 4) 1421 Second Street Luis Orlando Martinez See attached picture #4. Luis is still gutting and doing demo work inside. He has put on a new roof and repaired the siding. He has had his electrician complete the rough in, started drywall repairs, purchased and had delivered all new kitchen cabinets and is getting bids on the necessary basement repairs. Luis has been staying in contact with Cory since before the deadline approached.

We do feel that extensions should be granted but with continued supervision by the Building Inspector. The whole idea was to get these homes in a habitable condition, as soon as possible, making a home for someone instead of having to demolish it.

FINANCIAL IMPLICATIONS: N/A

RECOMMENDATION: It is recommended that:

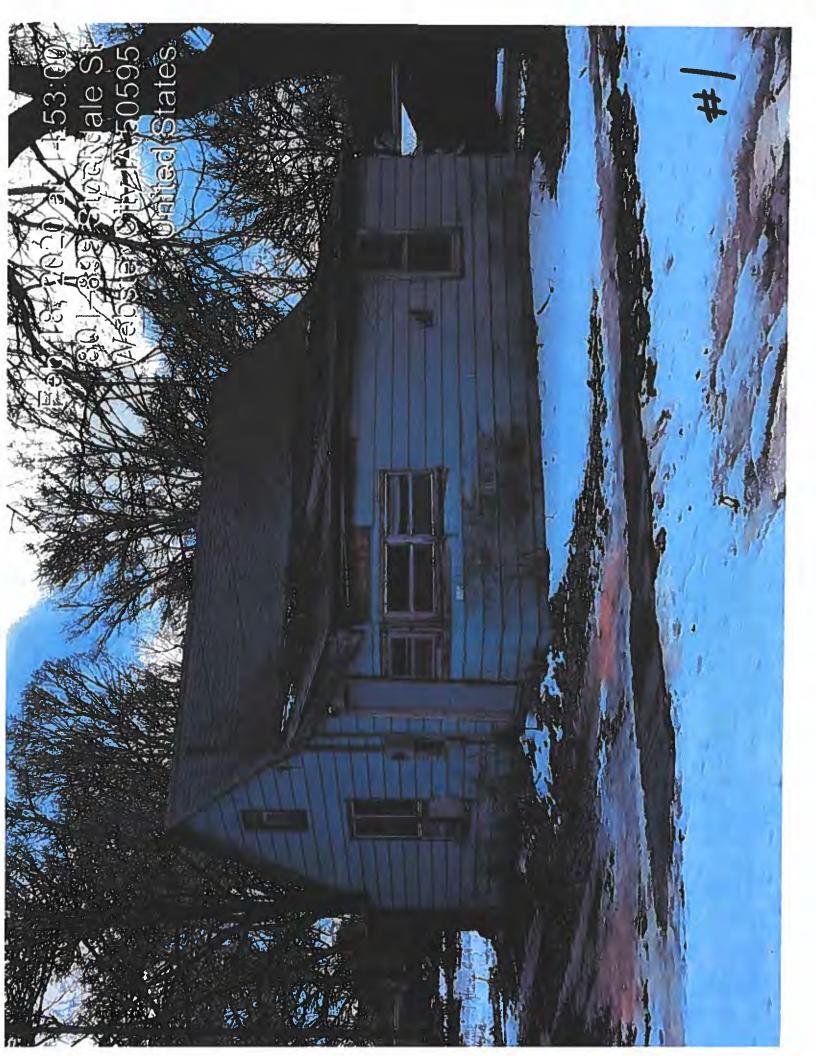

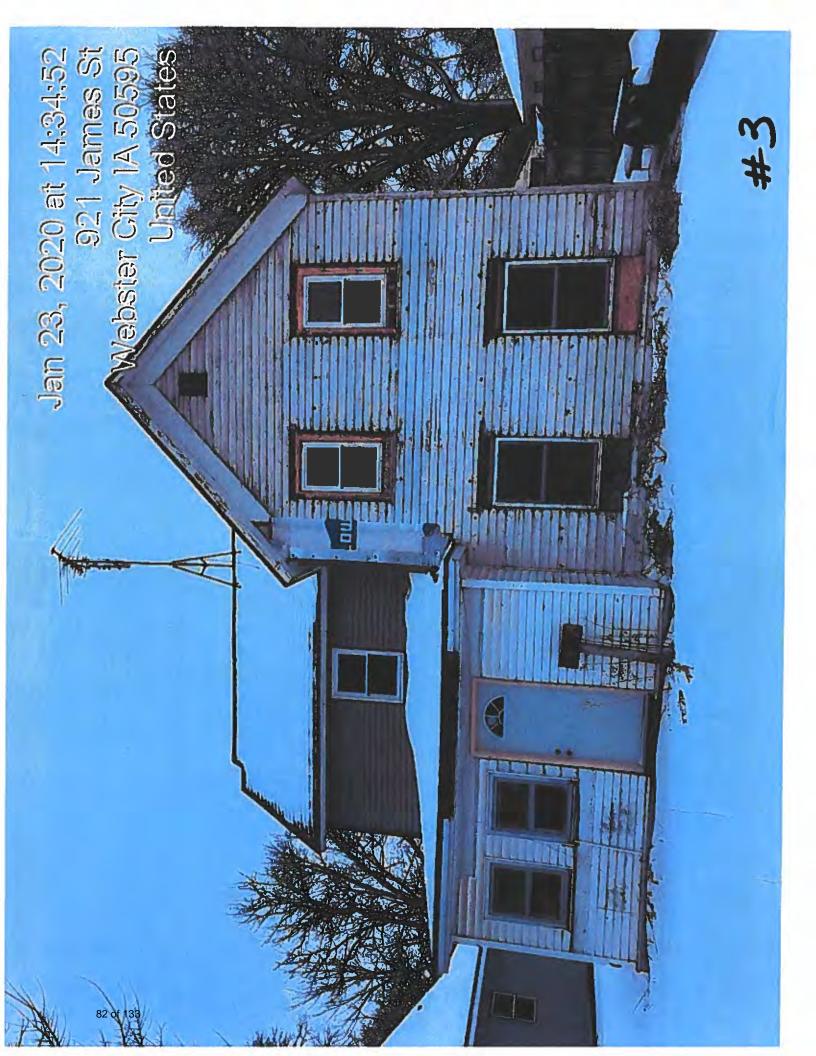

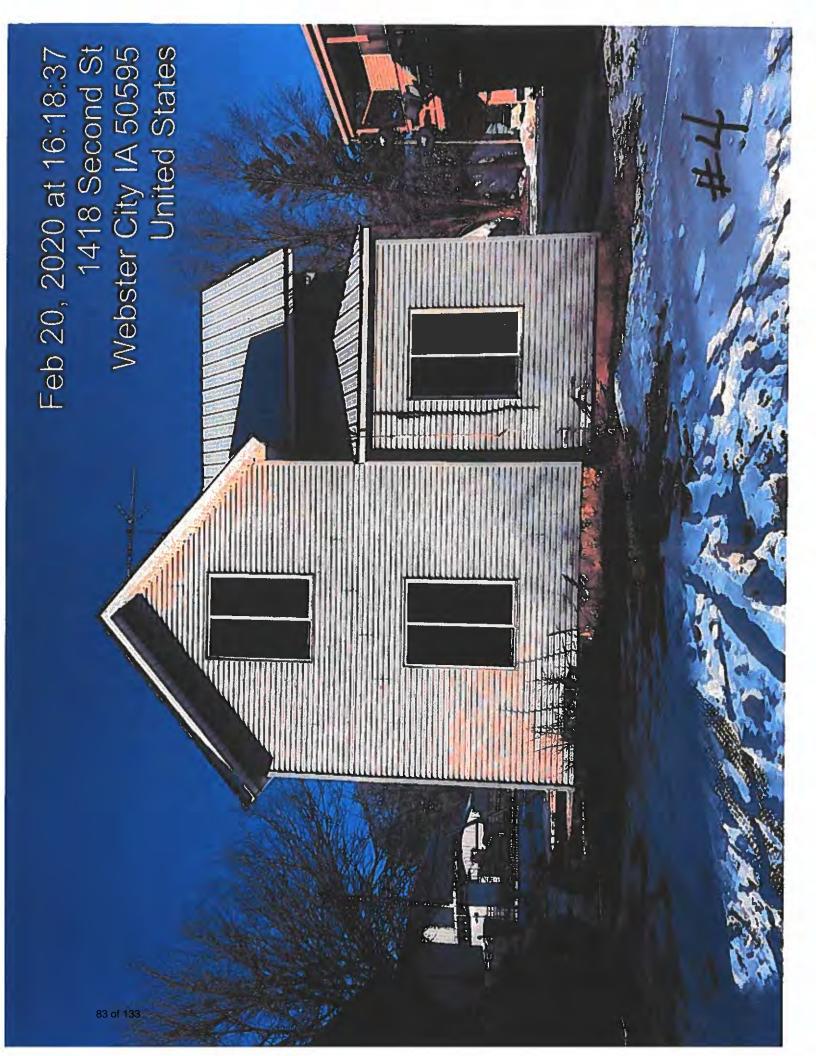

SUMMARY: At the meeting held on March 10, 2020, the Traffic Committee approved the recommendation to change the City Code of Ordinances to include six (6) stop signs at the intersections of Webster, Cedar, and Boone along Prospect Street.

The proposed ordinance will amend Chapter 46, Article II, Sec. 46-50 of the Code of Ordinances of the City of Webster City, Iowa 2019 by adding subsections (33), (34), and (35) as follows:

Section 46-50. Stop requirement at certain streets.

Every driver of a vehicle shall stop in accordance with the following:

- (33) Webster Street. Vehicles traveling on Webster Street shall stop at Prospect Street.
- (34) Prospect Street. Vehicles traveling on Prospect Street shall stop at Cedar Street.
- (35) Boone Street. Vehicles traveling on Boone Street shall stop at Prospect Street.

BACKGROUND/DISCUSSION: Council brought this issue before the Traffic Committee. Concerns discussed about this intersection were there had been several close calls and a recent accident at Cedar Street.

PREVIOUS COUNCIL ACTION: Council approved having a traffic study completed by Snyder and Associates on September 16, 2019.

FINANCIAL IMPLICATIONS: Council approved having a traffic study completed by Snyder and Associates on September 16, 2019 setting a not to exceed amount of \$2,800.00. Traffic Study is attached. To add the Stop Signs it will cost approximately \$200.00 per sign with six signs to be installed for a total of \$1,200.00.

RECOMMENDATION: The Traffic Committee recommends and Staff concurs to change the City Code of Ordinances to include six (6) stop signs at the intersections of Webster, Cedar, and Boone along Prospect Street.

ALTERNATIVES: Council could choose to have the Committee re-address the issue to find other alternatives.

PUBLIC WORKS DIRECTOR: I concur with the Traffic Committee's recommendation.

CITY MANAGER COMMENTS: I also agree with the recommendations of staff and the Traffic Committee.

Every driver of a vehicle shall stop in accordance with the following:

- (33) Webster Street. Vehicles traveling on Webster Street shall stop at Prospect Street.
- (34) Prospect Street. Vehicles traveling on Prospect Street shall stop at Cedar Street.
- (35) Boone Street. Vehicles traveling on Boone Street shall stop at Prospect Street.

SECTION 2. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 3. WHEN EFFECTIVE. This ordinance shall be in effect after its final passage, approval and publication as provided by law.

Summary

Based on the guidelines and analysis summarized in this memo, the current Unsigned (right-of-way traffic control) intersections along Prospect Street at Boone Street, Cedar Street, and Webster Street should be modified to two-way Stop Control. Following discussion with members of the Traffic Committee at the March 10, 2020 meeting, the two-way Stop control is recommended to provide Stop signs for eastbound and westbound movements at Boone Street and at Webster Street, and northbound and southbound movements at Cedar Street.

Background and Existing Conditions

Existing and recommended intersection traffic control were reviewed at study intersections along Prospect Street at Boone Street, Cedar Street, and Webster Street. The analysis included review of relevant traffic control, signing, and intersection design standards, as well as field review of the study intersections.

Figure 1 shows the corridor and study intersections. Prospect Street is a two-lane street that connects from Ohio Street to the south to Second Street, before terminating north of the railroad near the former Electrolux facility. Along the Prospect Street corridor, adjacent land use is primarily single family residential, with the Middle School campus to the east between Elm Street and Bank Street. Parking is allowed on the west side and restricted to the east. The speed limit is 25 mph by City ordinance (Section 46-81).

Table 1 summarizes the existing intersection traffic control along the Prospect Street corridor. The street network is a grid patterns, and the majority of the corridor has two-way Stop control (with all-way Stop control near the school), while the southern segment intersections are Unsigned. The pattern of two-way Stop control (TWSC) and/or Unsigned intersection control is common on surrounding corridors in this part of the City.

Traffic and Crash Data Collection

Review of crash data indicated 10 crashes across the three intersection from 2015-2019. Eight of the ten involved failure to yield right of way between an east/west vehicle and a north/south vehicle. Of those eight, six were property damage only and two had possible injuries.

The Engineer collected traffic and speed data in October 2019, and conducted intersection sight distance observations on November 6, 2019. Traffic volume and speed data indicated moderate traffic volumes (approximately 220 vehicles per day), and good speed compliance (Average speed: 22 mph, 85th Percentile Speed: 27 mph). Sight distance data is discussed in the *Analysis and Recommendations* section of this report. Traffic data details are attached in Appendix.

Design Guidelines for Analysis

The following guidelines and manuals were referenced to evaluate the intersection traffic control:

- Manual on Uniform Traffic Control Devices 2009 Edition (MUTCD),
- Iowa Statewide Urban Design and Specifications (SUDAS), and
- the American Association of State Highway and Transportation Officials A Policy of Geometric Design of Highways and Streets (AASHTO Green Book).

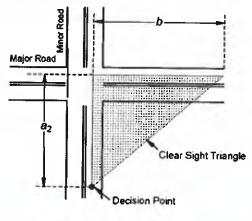
The alternatives considered were Unsigned (controlled by right of way), two-way Yield, two-way Stop control (TWSC), and all-way Stop control (AWSC).

Per the MUTCD, two of the guiding criteria for traffic control signing and marking are 'uniformity' and 'driver expectancy'. In this instance, as drivers travel south along Prospect Street in particular, or this area of the City in general, they will likely expect that a series of two-way Stop controlled intersections will continue along the corridor, and may not anticipate the other intersections may be Unsigned (controlled by rules of "right-of-way").

The governing criteria for these alternatives are traffic volumes, speeds, and intersection sight distance. As discussed regarding the traffic volume counts, traffic volumes on Prospect Street are very moderate. Minimum volume criteria for all-way Stop control (AWSC) per the MUTCD are not satisfied; therefore, AWSC is not appropriate along Prospect Street unless there is an additional reason such as a school pedestrian crossing or restricted sight distance in multiple directions. MUTCD Section 2B.04 provides additional guidance for Unsigned (right-of-way) and Yield and Stop controlled intersection signing. Two-way Yield controlled signing is not appropriate for the driver expectancy and uniformity reasons discussed above for the surrounding Stop controlled street network, and for sight distance restrictions due to adjacent housing structures. Therefore, the primary options evaluated are two-way Stop control (TWSC) and Unsigned.

Iowa SUDAS uses the intersection sight distance criteria for approach and departure sight triangles as provided in the AASHTO Green Book. Figure 2 shows example figures from the AASHTO Green Book. The sight distances needed for the sides of these 'sight distance triangles' varies considerably for Unsigned and two-way Stop control. For Unsigned (or Yield) controlled intersections, drivers approaching from both directions must be simultaneously able to observe conflicting traffic. As seen in Figure 2, this results in a long leg 'a' and leg 'b' as both drivers must have a clear view. At a Stop-controlled approach, the 'a' leg is much shorter as it represents the distance from the stopped driver's eye to the side of the intersecting street. The distance of the 'b' leg is based on the time the stopped driver needs to judge and complete their movement in a minimum gap, without conflict with the non-stopped driver. This distance is calculated based on the speed of the non-Stop controlled approach, and varies for left turn or right turn movements.

Based on AASHTO Green Book Chapter 9.5, the 'a' distance for Unsigned intersection signing would be 115 ft for posted speed limit of 25 mph, and 140 ft for a design speed of 30 mph. Given that most houses along Prospect Street intersection corners are set back approximately 30-40 ft from the curb, it is clear that there is not a clear sight triangle in the intersection corners for this Unsigned alternative, as illustrated in an example corner in Figure 3.

Next, two-way Stop controlled (TWSC) sight distances were checked for the various approaches at the three study intersections. The minimum 'b' distances for the passenger car design vehicle (3.5 ft driver height, 4.25 ft object height, measured from vehicle stopping point) are summarized in Table 2.

Most of the intersection approaches exceeded this intersection sight distance criteria for all potential east/west or north/south Stop control alternatives. As an example, the distance between blocks from Boone Street to Ohio Street ranges from approximatley 370-390 ft. At most intersection approaches, the next instersection could be seen from the side street approach, exceeding the minmum distances. Exceptions to this due to building structures, grading of yards, or trees are described at individual intersection summaries described below.

Additional consideration was given to potential to see oncoming traffic with existing street trees throughout study area. However, this issue is common throughout the City of Webster City. Specifically, once stopped, the driver may need to move slightly forward to confirm they have a clear path before proceeding. This is a necessary maneuver throughout the tree lined streets of the the City and nearly all approaches of the study intersections, and is necessary with presence of parked cars as well as street trees.

General Sign installation guidance (MUTCD)

The MUTCD provides guidance for installation of signs in Chapter 2A, and Stop signs in particular in Section 2B.05 and 2B.10. The following notes are provided:

- No other signs should be mounted on the same pole with a Stop sign other than street name signs.
- The Stop sign should be installed as close as practical to the intersection it regulates. However, where sidewalks are present, it should be 4 ft behind the marked crosswalk or edge of sidewalk. (MUTCD Figure 2A-3)
- The edge of the sign should be at least 2 ft from adjacent edge of street or edge of sidewalk. (MUTCD Figure 2A-3)
- Where pedestrian movements or parked vehicles are likely, the mounting height from the bottom of the near edge of pavement to the bottom of the sign should be 7 ft instead of standard 5 ft. (MUTCD Section 2A.18)

ITEM 1

- A) Enter the industry's Standard Industrial Classification Code Number (SIC Code). The 1987 edition of the "Standard Industrial Classification Manual" contains SIC code numbers and their descriptions.
- B) Specify the principal product(s) or the principal raw material(s) and the maximum quantity produced or consumed in any day. Quantities are to be reported in units of measurement found in the table "Standard Units of Measurement by SIC Code" on the next page. Other industrial SIC categories not included in the table should be listed in units of measurement normally used by the industry.
- ITEM 2 Hourly Maximum is the maximum discharge during any single hour in the peak period of operation.
- ITEM 6 Describe all pretreatment of waste prior to discharge to municipal collection system.
- ITEM 7 Describe any occasional or intermittent discharge and include the frequency of discharges and the amount. Such discharges could upset a treatment plant because of the shock effect of a sudden change in influent loading.
- ITEM 8 <u>Compatible Waste in Contribution</u> means any waste parameter discharged that the receiving treatment works was designed to treat and does remove to a significant degree. <u>Average</u> is to represent the maximum 30-day average likely to occur in any year. Days when no discharge occurs should not be included in the average. <u>Maximum</u> is the maximum single-day contribution during a peak period of operation.
- ITEM 9 <u>Incompatible Waste in Contribution</u> means any waste not qualifying within the definition in Item 8. List all such waste parameters that are contributed in concentrations greater than that present in the raw water supply.

*NOTE: A "Significant industrial user" means an industrial user of a publicly-owned treatment works (POTW) that meets any one of the following conditions:

- 1. Discharges an average of 25,000 gallons per day or more of process wastewater excluding sanitary, noncontact cooling and boiler blowdown wastewater;
- 2. Contributes a process waste stream which makes up 5 percent or more of the average dry weather hydraulic or organic capacity of the POTW;
- 3. Is subject to Categorical Pretreatment Standards under 40 CFR 403.6 and 40 CFR Chapter I, Subchapter N; or
- 4. Is designated by the department as a significant industrial user on the basis that the contributing industry, either singly or in combination with other contributing industries, has a reasonable potential for adversely affecting the operation of or effluent quality from the POTW or for violating any pretreatment standards or requirements.

Upon a finding that an industrial user meeting the criteria in paragraph "1" or "2" of this definition has no reasonable potential for adversely affecting the operation of the POTW or for violating any pretreatment standard or requirement, the department may, at any time on its own initiative or in response to a request received from an industrial user or POTW, determine that an industrial user is not a significant industrial user.

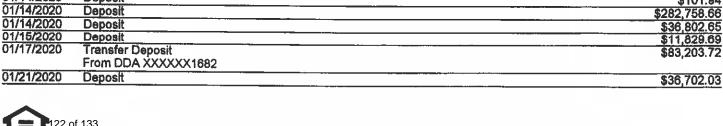

Dear Council Members:

Outlined below is a summary of professional services I have provided for the City of Webster City as City Attorney for the month of March 2020. The main issues I addressed this past month were (a) preparing the necessary transfer documents to sell City-owned property located at 509 Cherry Street, (b) preparing the necessary transfer documents to sell a portion of City-owned property located at 209 E. Dubuque Street, (c) prepared the necessary documents for the City to purchase a piece of property located at 748 Second Street to widen the alley located behind said property, and (d) continued work on the final platting for the Lynx Development.

In regards to the City-owned property located on Cherry Street, I worked with the City's Planning Director to work through the notice, sealed bid, and purchase agreement process. I also prepared all the transfer documents to now transfer ownership of said property to the highest bidder.

In regards to the City-owned property located on Dubuque Street, I worked with the City's Planning Director to work through the purchase agreement and subsequent transfer documents to sell a portion of said property to the adjoining property owner to cure a previous driveway issue.

In regards to the property located at 748 Second Street, the City needs to purchase a portion of said property from it's owner in order to widen the alley located behind the property to accommodate truck traffic to the Daily-Freeman Journal. I have prepared the necessary documents to facilitate said transfer once approved.

Finally, in regards to the final platting of Lynx Development located on Edgewood Drive, I have been working with the developer's attorney to ensure all the necessary documents for the final plat are in order. Said final plat is nearly ready to be presented to the Council for approval.
