4. It was moved by Miller and seconded by McKinney that request from Recreation and Public Grounds Assistant Director to seek bids for the Tuckpointing, Repair and Cleaning of the Limestone Entry Walls at Kendall Young Park, and authorization to proceed if the bids come in under the budget amount of \$16,000 be approved.

5. It was moved by Welch and seconded by Miller that request from Street Superintendent to seek bids for a pickup truck with utility box, and approval to purchase if the bids come in under the budget amount of \$49,000 be approved.

6. It was moved by Hartmann and seconded by McKinney that request from Water Plant Superintendent to purchase a Kasco Municipal Tank Mixer from Great Northern Environmental for the Ground Storage Water Reservoir Tank in the amount of the quote of \$8,750 be approved.

7. It was moved by Miller and seconded by Hartmann that request from Line Department Superintendent to purchase, with installation, a "Hot Box" attachment for the 2018 McLaughlin Vacuum Excavator from Vermeer Corporation in the amount of the quote of \$6,600 + tax, be approved.

8. It was moved by McKinney and seconded by Hartmann that request from Fire Chief to purchase Turnout Gear for the Fire Department from Danko Fire Equipment in the amount of the quote of \$12,692.50 be approved.

- 3. The purpose of the Work Session was to hold a discussion on Fiber Optic Network. Public Works Director Wetzler provided a map to Council showing the Fiber Optic Ring currently in place. He also provided a timeline dating back to 1961 on the various council actions, studies conducted and election establishing a Broadband Communication System. Michael Maloney, D.A. Davidson, had previously provided Council Members with a memo addressing Webster City's Fiber Future that included City Fiber/Broadband Deployment, what models are available to pursue and actions

Council should consider in the coming weeks. Curtis Dean of Smart Source Consulting, spoke on the Municipal Utilities in Iowa that are exploring, are in the beginning stages or currently have fiber optic deployment in their cities or communities.

Council Members provided consensus for City Manager Sheridan, Mr. Maloney and City Staff to continue to explore and evaluate options on the Fiber Optic Network and report back to Council at a later date.
