Biridiana Bishop, Assistant City Manager, provided information and estimated timeline for this Hearing process.

c. It was moved by McKinney and seconded by McFarland that Resolution No. 2023-013 setting January 16, 2023 at 6:05 p.m. in Council Chambers at City Hall, Webster City, Iowa for a Public Hearing at which it is proposed to Approve a Development Agreement with Peoples Credit Union, including Annual Appropriation Tax Increment Payment be passed and adopted.

d. Discussion on the Webster City Day Care was held in regard to a recent proposal to remodel the Center to accommodate more spots for Day Care. Daniel Ortiz-Hernandez, City Manager, provided a brief history of the acquisition and funding of the Webster City Day Care and informed Council that the City is still the Deed holder of the property. For any project concerning the Day Care, the proper procurement process would need to be taken using the guidelines outlined by the State for Government Public Entities. The possibility of the City providing matching funds of what Hamilton County Board of Supervisors has pledged to the project was also discussed. Consensus of Council was to direct Staff to change the structure of the loan for the Webster City Day Care and follow the procedures needed for the Deed to be transferred. Once this is completed, Council will consider the additional monies requested, pursuant to having an agreement stating the public purpose for the funding.

It was moved by McKinney and seconded by Hansen that council adjourn.
